NOTICE 2025

THE COUNCIL OF THE CITY AND COUNTY OF SWANSEA in exercise of the powers conferred by Section 16A of the Road Traffic Act 1994 and with consent from Welsh Government, **HEREBY GIVE NOTICE** that on the various dates as shown in the Schedule below and as and when the appropriate traffic signs are displayed no person shall cause a vehicle (other than a vehicle being used for emergency purposes) to proceed along the length or lengths of road(s) referred to in the Schedule below.

SCHEDULE

Due to the expected crowds of people who are likely to attend the Uplands Market at Gwydr Square, it is considered necessary to close the section of highway known as Gwydr Square from the junction of A4118 Uplands Crescent to Ernald Place, to prevent the likelihood of danger to the public. The following roads will therefore be closed between 06:00hrs and 14:30hrs on the dates below: -

Gwydr Square, Gwydr Crescent (part) and Beechwood Road (part) from the junction of A4118 Uplands Crescent to Ernald Place.

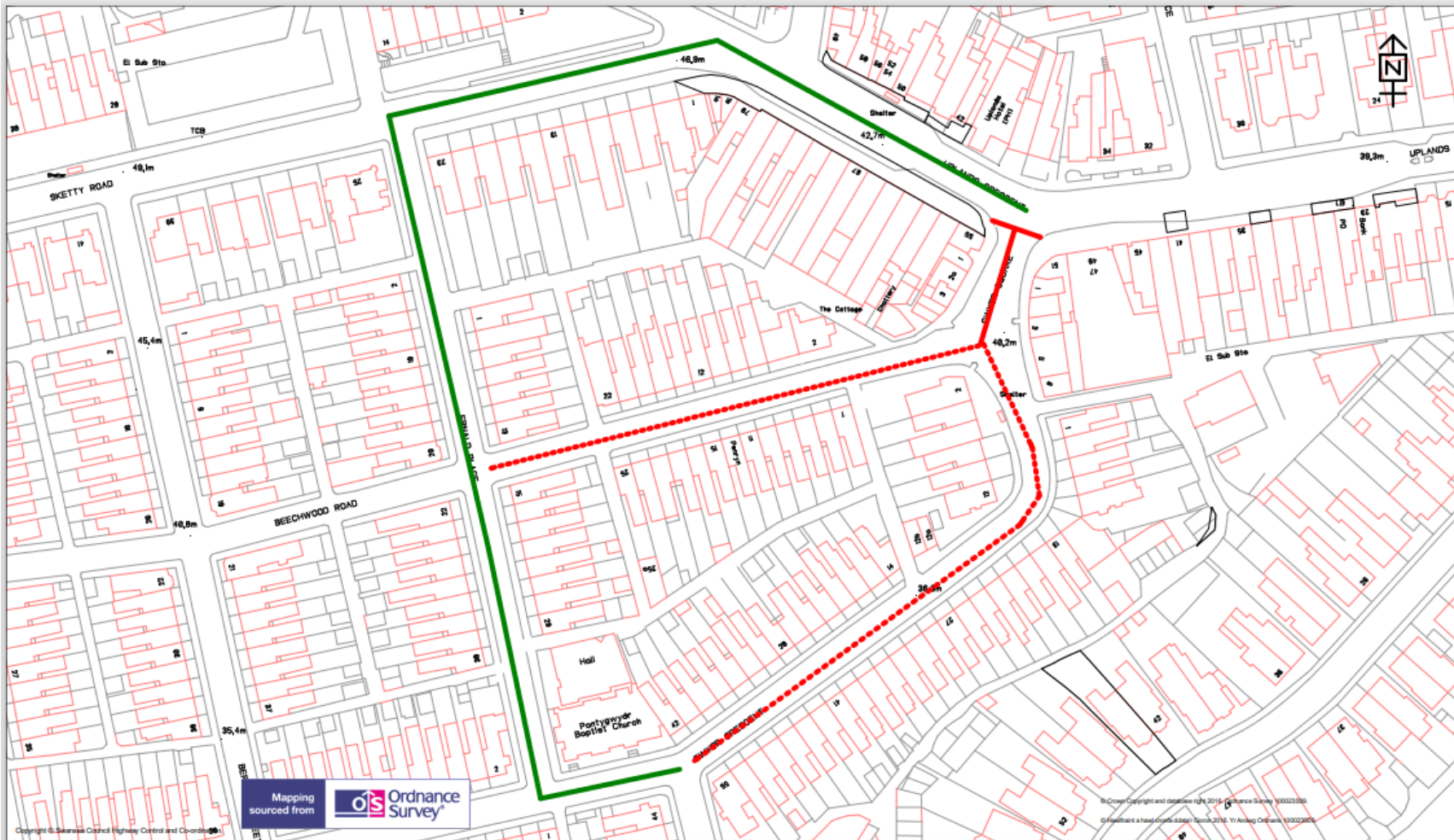
