## SCHEDULE 1- TEMPORARY ROAD CLOSURE THISTLEBOON ROAD, VILLAGE LANE AND WESTERN LANE MUMBLES, SWANSEA

Thistleboon Road, in a southerly direction to its junction with Tichbourne Street a distance of approximately 30 metres.

There is no alternative route for vehicular traffic residents will have marshalled access.

#### SCHEDULE 2- TEMPORARY ROAD CLOSURE VILLAGE LANE MUMBLES, SWANSEA

Village Lane, from its junction with Thistlebourne Road in a northerly direction a distance of approximately 30 metres.

There is no alternative route for vehicular traffic residents will have marshalled access

#### SCHEDULE 3- TEMPORARY ROAD CLOSURE WESTERN LANE MUMBLES, SWANSEA

Western Lane, in a northerly direction to its junction with Mumbles Road a distance of approximately 200 metres.

- 1. Thistleboon Road at its junction with Higher Lane/New Villas.
- 2. Village Lane at its Junction with Mumbles Road



### <u>SCHEDULE 5 – MARSHALLED TEMPORARY REVOCATION OF ONE WAY</u> THISTLEBOON ROAD, VILLAGE LANE, MUMBLES, SWANSEA

- 1. Thistleboon Road from its junction with Higher Lane/New Villas to its junction with Tichbourne Street a distance of approximately 180m, Marshalled access for residents only.
- 2. Village Lane from its Junction with Mumbles Road for a distance of approximately 150m, Marshalled access for residents only.
