NOTICE 2024**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Thursday 13th July 2024** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 2 days to complete), no person shall cause any vehicle to be driven as referred to in the schedule below. In order for MJ Quinn on behalf of BT Openreach to repair a collapsed carriageway chamber at the above location, it will be necessary to temporarily close the above road to vehicular traffic.

**SCHEDULE - TEMPORARY EMERGENCY ROAD CLOSURE
KYFTS LANE, LLANMADOC, GOWER.**

Kyfts Lane from its junction with Cheriton Road (Britannia Inn) in an southerly direction to its junction with North Road (Kennexstone Farm), a distance of approximately 2 kilometres.

The alternative route for vehicular traffic will be via the North Road and the Cheriton Road, a distance of approximately 8.5 kilometres.

Similarly this route will operate in the reverse direction.

Access for emergency vehicles and pedestrians to be maintained at all times.

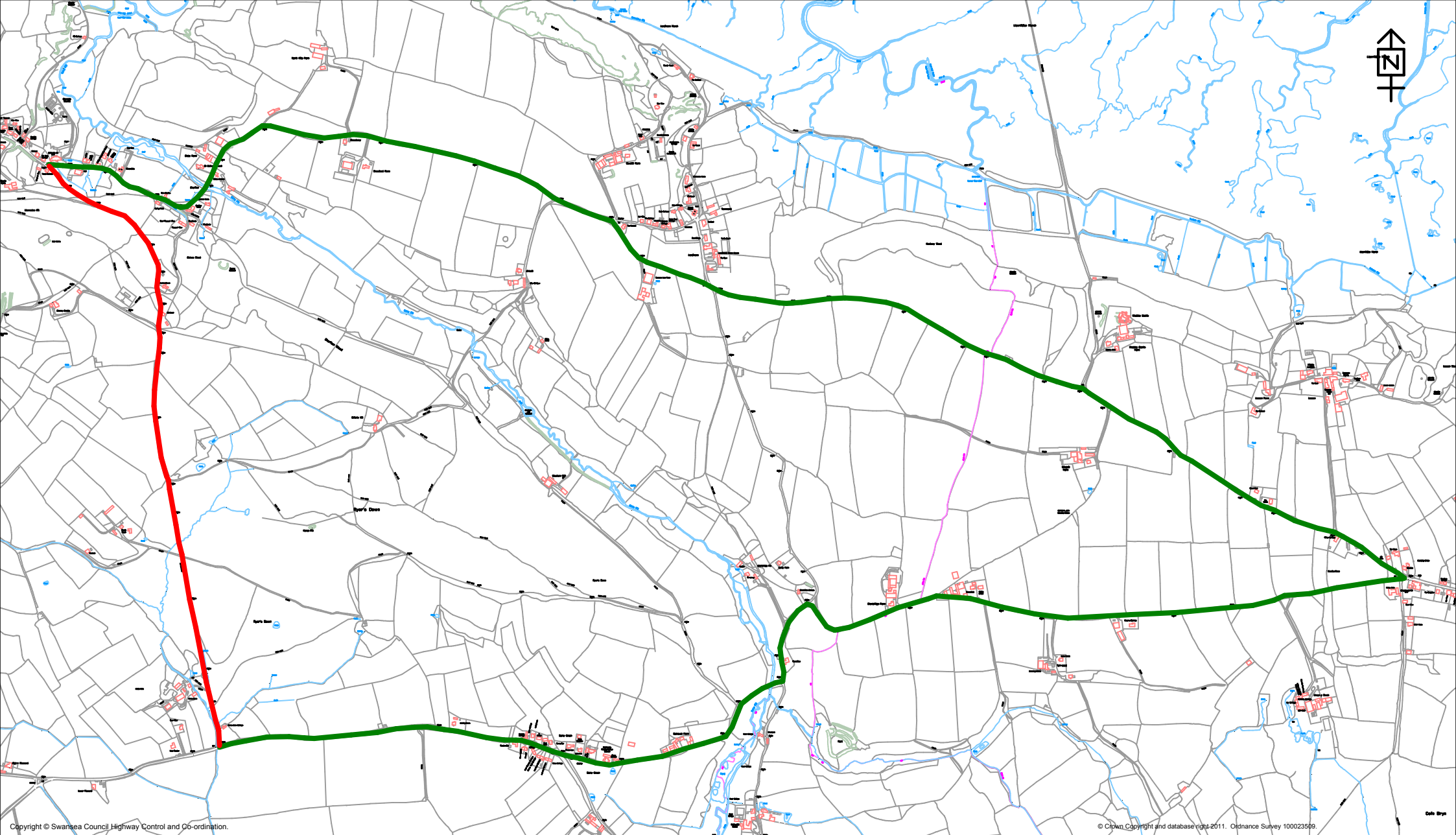
