NOTICE is hereby given that the Council of the City and County of Swansea in pursuance of its powers under the Road Traffic Regulation Act 1984 (as amended) intend to close the above-mentioned road. In order for City & County of Swansea Council to undertake Patch repairs to the highway network it will be necessary to temporarily close the above roads to vehicular traffic.

Harcourt Street from its junction with Terrace Road in a south-easterly direction to its junction with Norfolk Street, a distance of approximately 60 metres.

The alternative route for vehicular traffic will be via Terrace Road, Stanley Place and Norfolk Street, a distance of approximately 140 metres.

Due to Stanlet Street being one way in part the diversionary route will only operate in the clockwise direction.

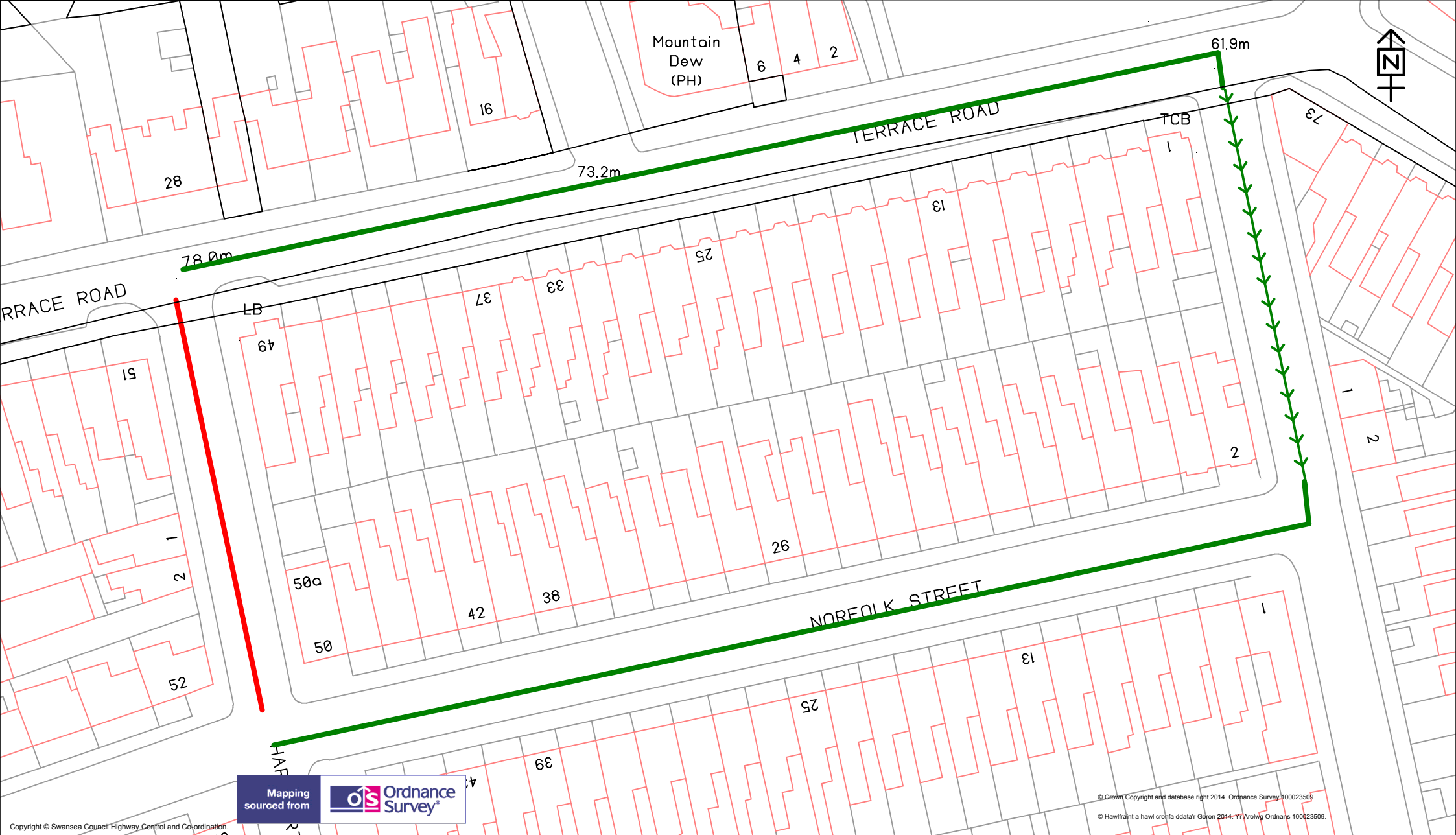
Access for emergency vehicles and residents to be maintained at all times.
