NOTICE 2024**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Tuesday 25th June 2024** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 3 days to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for Dwr Cymru Welsh Water to undertake repairs to a burst water main, it has been necessary to temporarily close the above road to vehicular traffic.

**SCHEDULE – TEMPORARY EMERGENCY ROAD CLOSURE
UNNAMED Y2272, REYNOLDSTON, GOWER SWANSEA.**

Y2272 adjacent to Hennyswell Farm in a south easterly direction for a distance of approximately 50 metres.

The alternative route for vehicular traffic will be via, the unaffected section of Unnamed Y2272, C175 (road to Ferry Hill), Unnamed C169 (North Road) Unnamed B4271 (North Gower Road), Unnamed Y2227 (Cefn Bryn) and the unaffected section of Unnamed Y2272, a distance of approximately 11.5 kilometres.

This route will operate in the opposite direction and **is suitable for light vehicles only.**

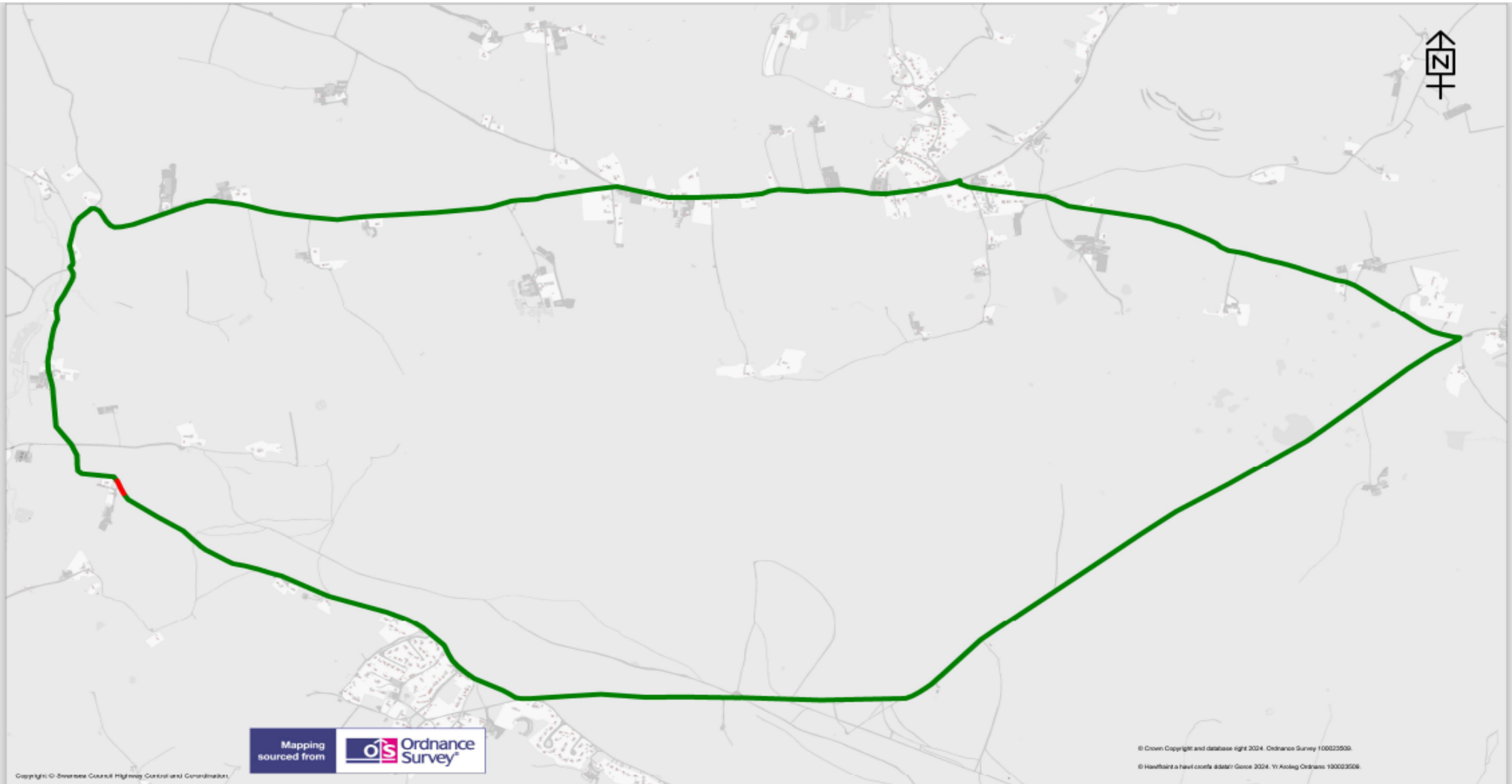
Access for emergency vehicles and pedestrians to be maintained at all times.

The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
