NOTICE 2024**

**NOTICE** is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14(1)(b) of the Road Traffic Regulation Act 1984 (as amended) that from Thursday 11<sup>th</sup> July 2024 for a period of 21 days only (or until the restrictions related to the event are no longer needed whichever is sooner – it is anticipated that the restrictions will be needed for 2 days, no person shall cause any vehicle to be driven as referred to in the schedule below.

**SCHEDULE**

Love Trail Is Festival Ltd is to hold a Love Trail Festival at Weobley Castle from 12:00hrs on Thursday 11<sup>th</sup> July 2024 until 12:00hrs Monday 15<sup>th</sup> July 2024. As a result, it is considered necessary, in the interests of safety to temporarily reduce the speed limit and introduce a One-way system to vehicular traffic on Cheriton Road (via Weobley Castle) for the duration of the event.

- The One-way westerly traffic system between Leason and Landimore will be in place on (arrival days) Thursday 11<sup>th</sup> July and Friday 12<sup>th</sup> July only.
- Temporary road crossing and 10mph speed limit in place outside the Love Trails Festival gate between the main festival field and camping field for the safety of festival ticketholders, from Thursday 11<sup>th</sup> July 12:00 - Monday 15<sup>th</sup> July 12:00 only.

Would you therefore please commence the statutory procedures under Section 14(b) of the Road Traffic Regulation Act 1994, Special Events Closure, to introduce a 10mph restriction and one-way system on Cheriton Road/Weobley Castle Road on Thursday 11<sup>th</sup> July 2024 until Monday 15<sup>th</sup> July 2024.

**Access for emergency vehicles to be maintained at all times.**

The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
