VICTORIA ROAD, PENCLAWDD, SWANSEA
NOTICE 2024**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Monday 29th July 2024** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 2 weeks to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for Swansea Council to undertake drainage repair works, it will be necessary to temporarily close the above-named road to vehicular traffic.

SCHEDULE – EMERGENCY TEMPORARY ROAD CLOSURE
VICTORIA ROAD, PENCLAWDD, SWANSEA

Victoria Road in a south-easterly direction from its junction with Dunraven Close to its junction with Ael y Bryn and Old Colliery Road, a distance of approximately 210 metres.

The alternative route for vehicular traffic will be via the unaffected section of Victoria Road, (B4295) Beach Road, (B4295) Glanmor Terrace, (B4295) Seaview Terrace, (B4295) Belle View Terrace, (B4295) Bowens Terrace, (B4295) Blodwen Terrace, (B4295) Station Road, (C156) Hendy Road, (C156) Blaencedi, Blue Anchor Road, and the unaffected section of Victoria Road a distance of approximately 2.7 kilometres.

This route will operate in the opposite direction and is suitable for light traffic only.

Access for emergency vehicles to be maintained at all times.

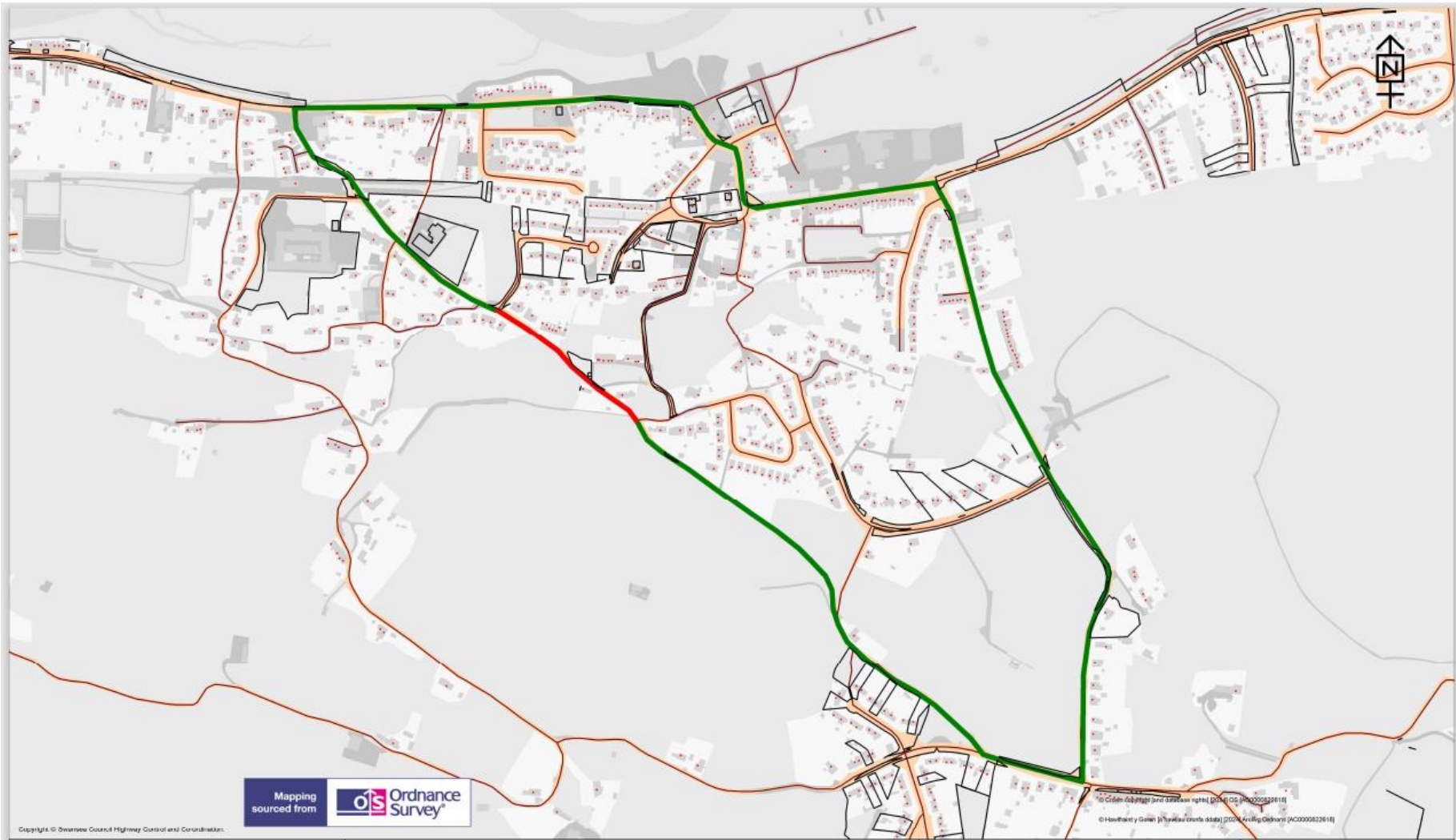
