NOTICE 2024**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Thursday 25th July 2024** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 7 days to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for Dwr Cymru Welsh Water to undertake repairs to a burst water main, it has been necessary to temporarily close the above road to vehicular traffic.

SCHEDULE - TEMPORARY EMERGENCY ROAD CLOSURE
HEOL LAS, BIRCHGROVE

Heol Las in an easterly direction from its junction with Gwernllwnchywth Road to its junction with Heol Nant Bran, a distance of approximately 420 metres.

The alternative route for vehicular traffic will be via Gwernllwnchywth Road, B4625, B4291 Birchgrove Road and the unaffected section of Heol Las, a distance of approximately 3.5 kilometres. Similarly this route will operate in the reverse direction.

Access for emergency vehicles and pedestrians to be maintained at all times.

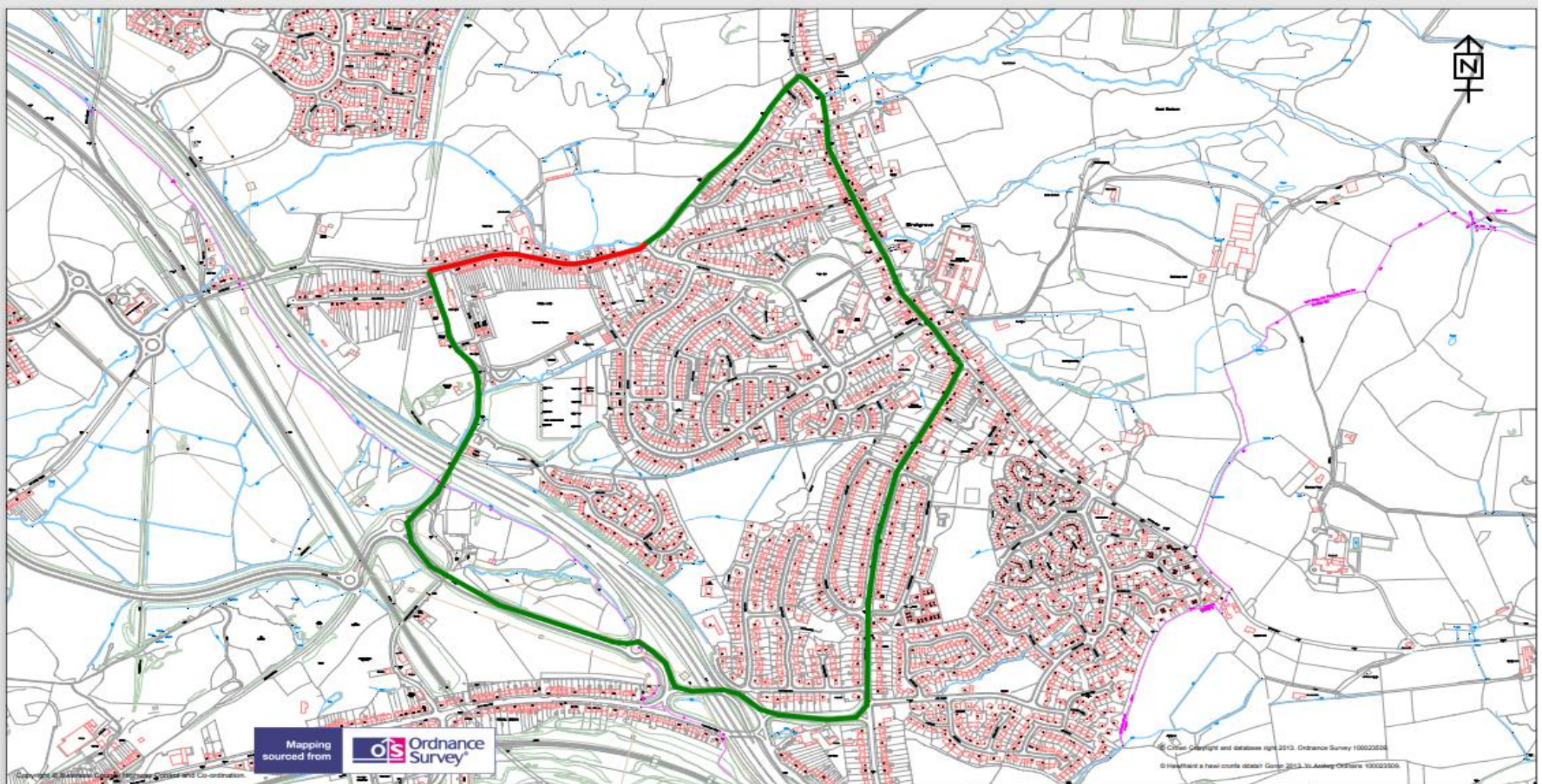
The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
