NOTICE 2024**

**NOTICE** is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **6<sup>th</sup> August 2024** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 3 days to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for Morrisons Water Services on behalf of Dwr Cymru Welsh Water to undertake remedial leakage works at the above location, it has been necessary to temporarily close the above road in part to vehicular traffic.

**SCHEDULE - TEMPORARY EMERGENCY ROAD CLOSURE**  
**GOPPA ROAD, PONTARDDULAIS**

Goppa Road in a northerly direction from its junction with Highland Terrace to outside 109 Goppa Road, a distance of approximately 130 metres.

The alternative route for vehicular traffic will be via A48 Bolgoed, Alltiago Road, Caecerrig Road, Upper Mill Road and the unaffected section of Goppa Road, a distance of approximately 2.3 kilometres.

This route will operate in the reverse direction and is suitable for light vehicles only.

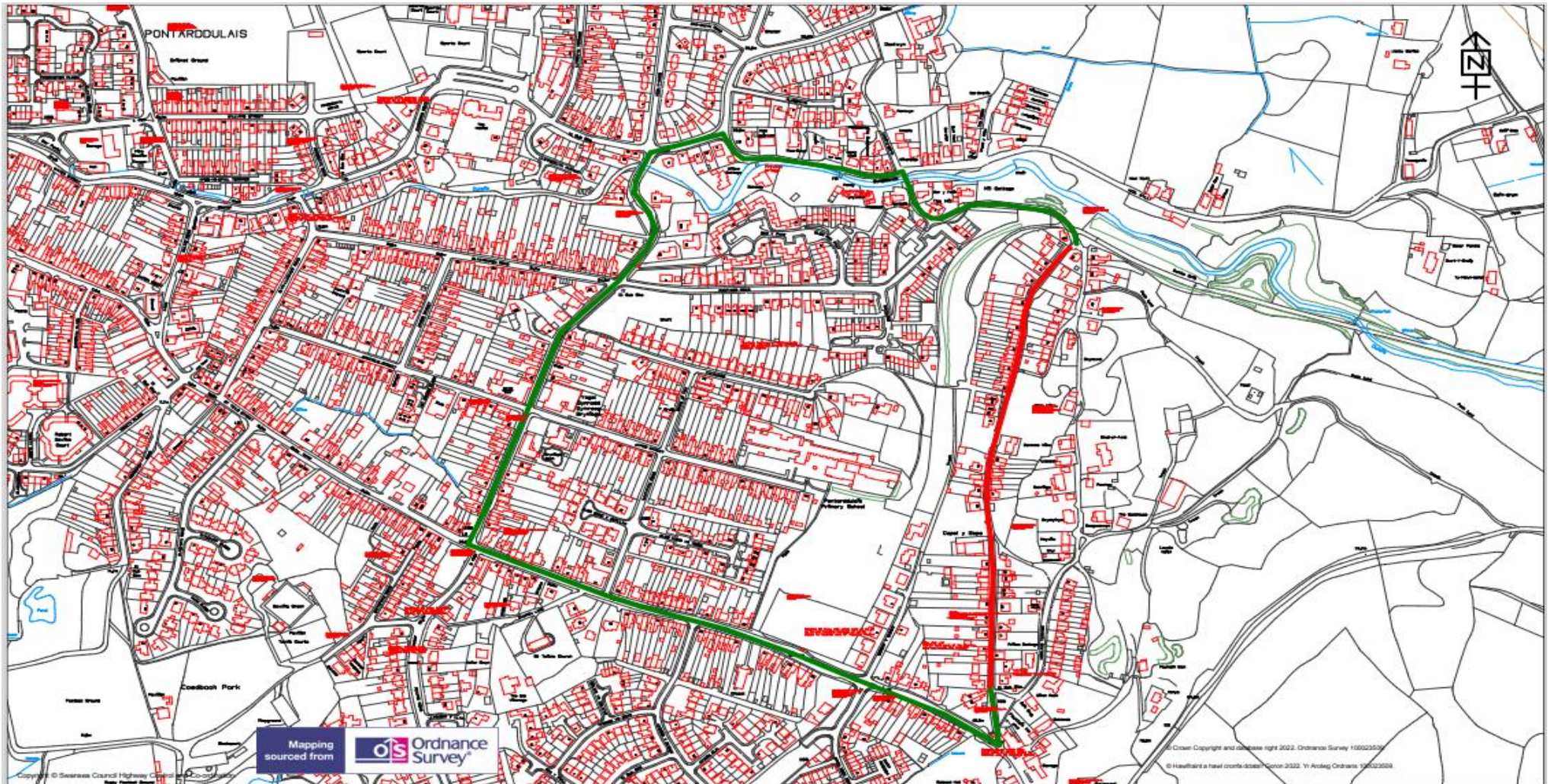
**Access for emergency vehicles to be maintained at all times.**


The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
