NOTICE 2024**

**NOTICE** is hereby given that the Council of the City and County of Swansea in pursuance of its powers under the Road Traffic Regulation Act 1984 (as amended) intend to close the above-mentioned road. In order for City & County of Swansea Council, Highway Maintenance section to undertake Pothole repairs, Gully Cleaning and Sidings work at the above location, it will be necessary to temporarily close the above road in part to vehicular traffic.

**SCHEDULE - TEMPORARY ROAD CLOSURE**  
**A484 LOUGHOR BYPASS (EASTBOUND), SWANSEA**

A484 Loughor Bypass from its junction with Castle Street (A4240), in an easterly direction to its junction with Victoria Road (B4296), a distance of approximately 3 Kilometres.

The alternative route for vehicular traffic will be via A4240 Castle Street, B4620 Glebe Road, B4620 Loughor Road and B4296 Victoria Road, a distance of approximately 3.5 kilometres.

Similarly, this route will operate in the reverse direction.

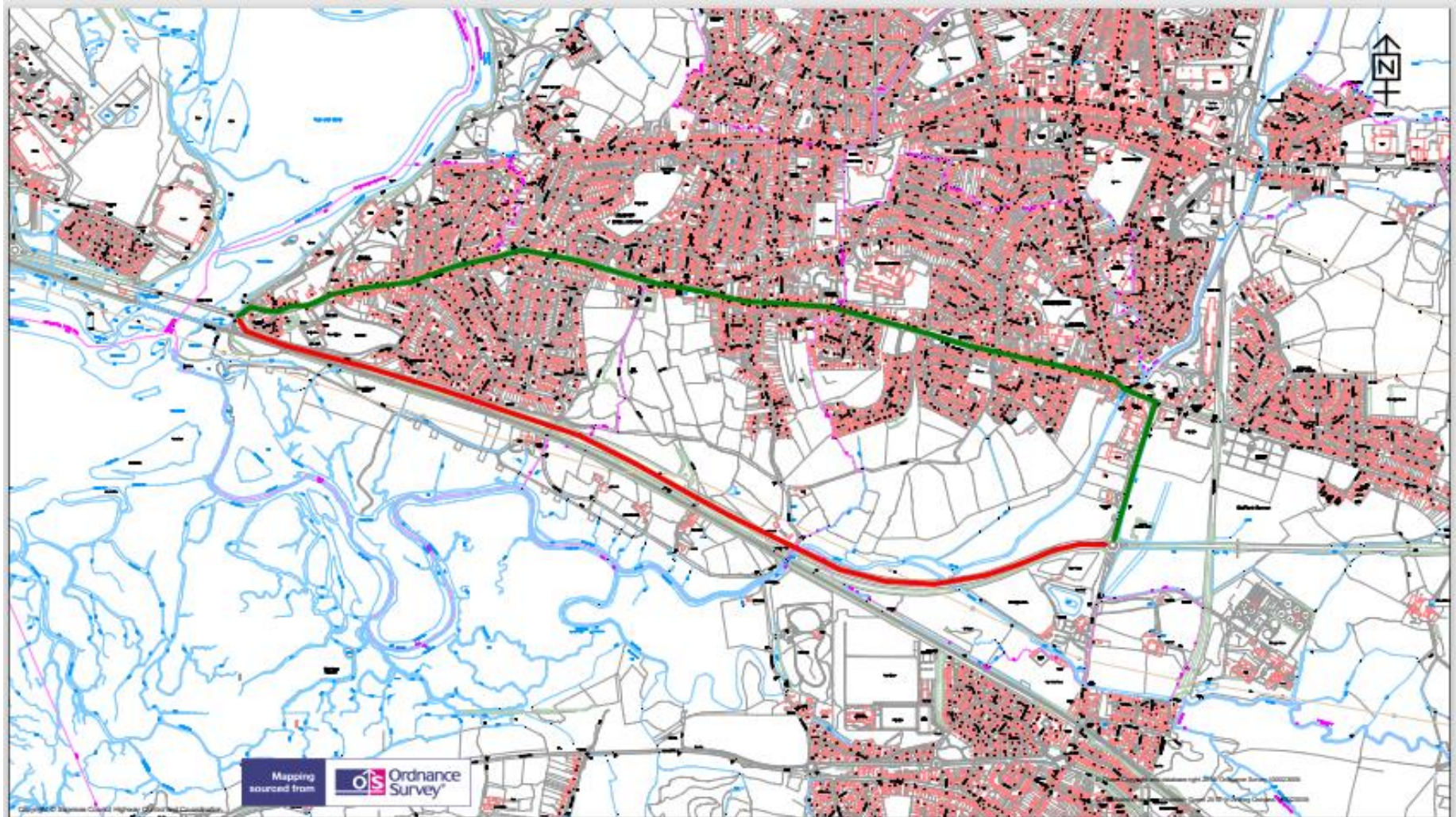
**Access for emergency vehicles to be maintained at all times.**
