NOTICE 2025**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Monday 6th January 2025** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 3 days to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for Dwr Cymru Welsh Water to carry out emergency mains repair works it has been necessary to temporarily close the above road in part vehicular traffic.

SCHEDULE - TEMPORARY EMERGENCY ROAD CLOSURE
WERN ROAD, LLANMORLAIS

Wern Road in a southerly direction from its junction with Station Road to 96715510side property named Woodlands, a distance of approximately 50 metres.

There is no alternative route for vehicular traffic; road plates will be used to allow vehicle access and egress.

Access for emergency vehicles and pedestrians to be maintained at all times.


The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
