NOTICE 2025**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Wednesday 8th January 2025** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 10 days to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for Wales and West Utilities to repair a gas leak at the above location, it has been necessary to temporarily close the above road to north bound vehicular traffic only.

TEMPORARY EMERGENCY ONE WAY NOTICE / ROAD CLOSURE
B4603 MARTIN STREET, MORRISTON, SWANSEA

B4603 Martin Street in a south-easterly direction from its junction with Morfydd Street to its junction with Banwell Street, a distance of approximately 95 metres.

The alternative route for vehicular traffic will be via the unaffected section of B4603 Martin Street, A4067 Neath Road, A48 Clase Road and B4603 Woodfield Street, a distance of approximately 1.6 kilometres.

Access for emergency vehicles, pedestrians and residents to be maintained at all times.


The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
