NOTICE 2025**

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Friday 17th January 2025** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 5 days to complete), no person shall cause any vehicle to be driven along the length or lengths of road(s) referred to in the Schedule below. In order for National Grid to repair a damaged main electric cable at the above location, it has been necessary to temporarily close the above road in part to vehicular traffic.

**SCHEDULE – TEMPORARY EMERGENCY ROAD CLOSURE
HEATHFIELD, MOUNT PLEASANT**

Heathfield in a south-westerly direction from its junction with Mount Pleasant for a distance of approximately 100 metres.

The alternative route for vehicular traffic will be via the unaffected section of Heathfield, Primrose Hill, Cromwell Street, Stanley Street, and Mount Pleasant, a distance of approximately 1 kilometre.

Similarly, this route will operate in the reverse direction.

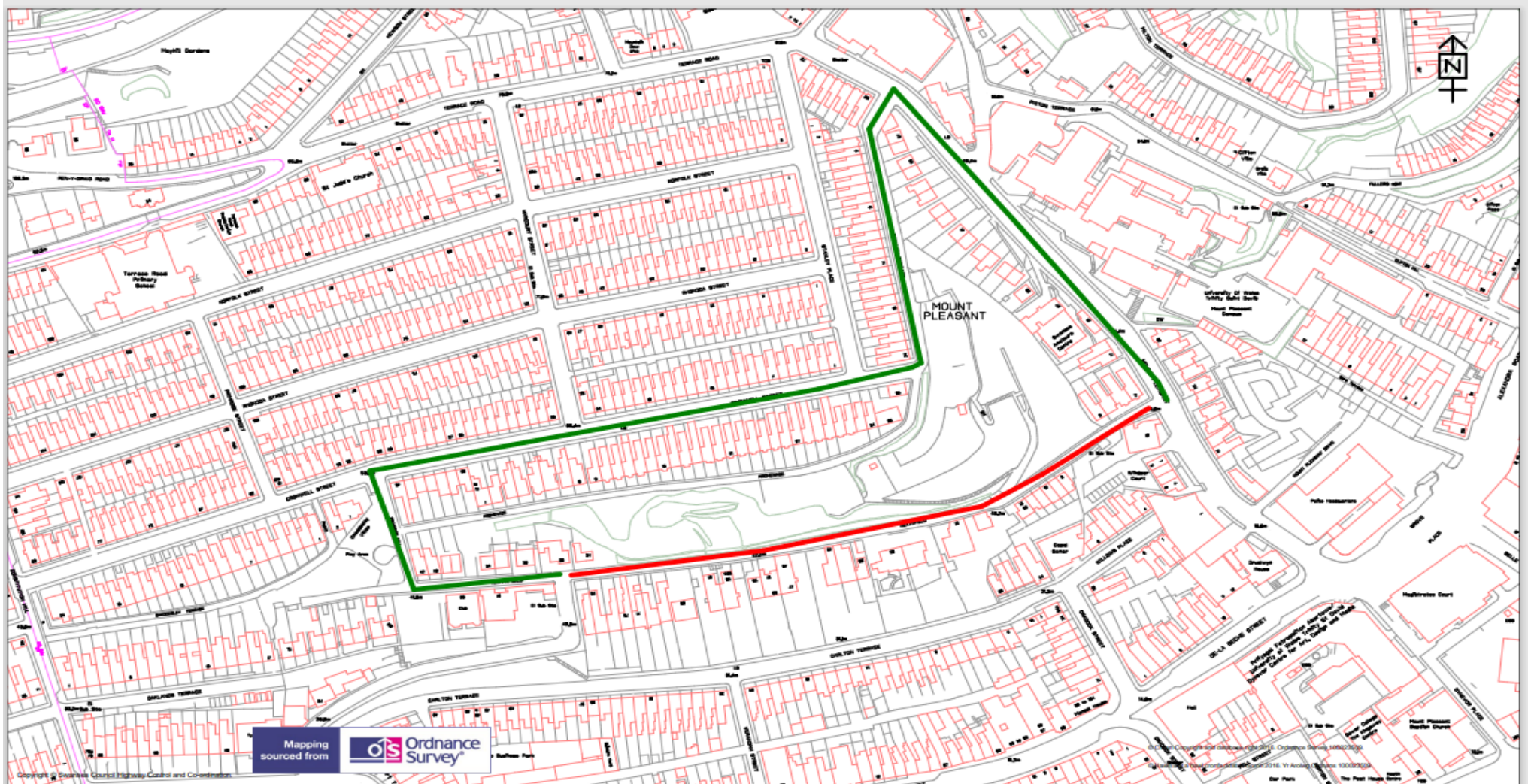
Access for emergency vehicles and pedestrians to be maintained at all times.


The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
