NOTICE 2025

NOTICE is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from **Tuesday 2nd December 2025** for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 3 days to complete), no person shall cause any vehicle to be driven as referred to in the schedule below. In order for Swansea Council Parks Department to carry out tree felling on Penlan Crescent, it will be necessary close the above road in part to vehicular traffic.

SCHEDULE – TEMPORARY EMERGENCY ROAD CLOSURE
PENLAN CRESCENT, UPLANDS, SWANSEA

Penlan Crescent in a south-easterly direction from its junction with Notts Gardens to its junction with Cwmdonkin Drive, a distance of approximately 20 metres.

The alternative route for vehicular traffic will be via Cwmdonkin Drive, Uplands Terrace, A4118 Uplands Crescent, Glanmor Road and the unaffected section of Penlan Crescent, a distance of approximately 1.5 kilometres.

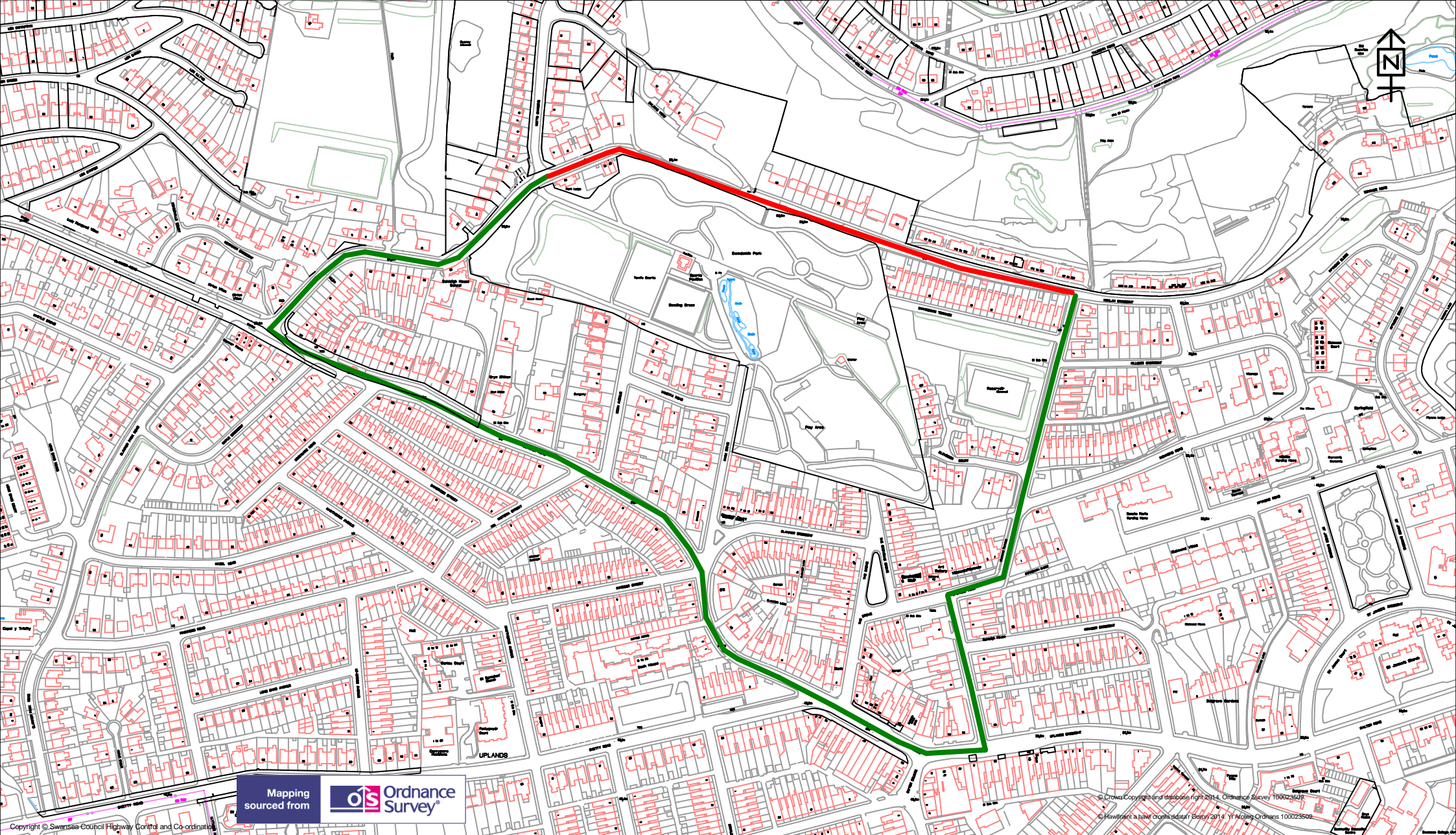
Access for emergency vehicles and pedestrians to be maintained at all times.

The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
