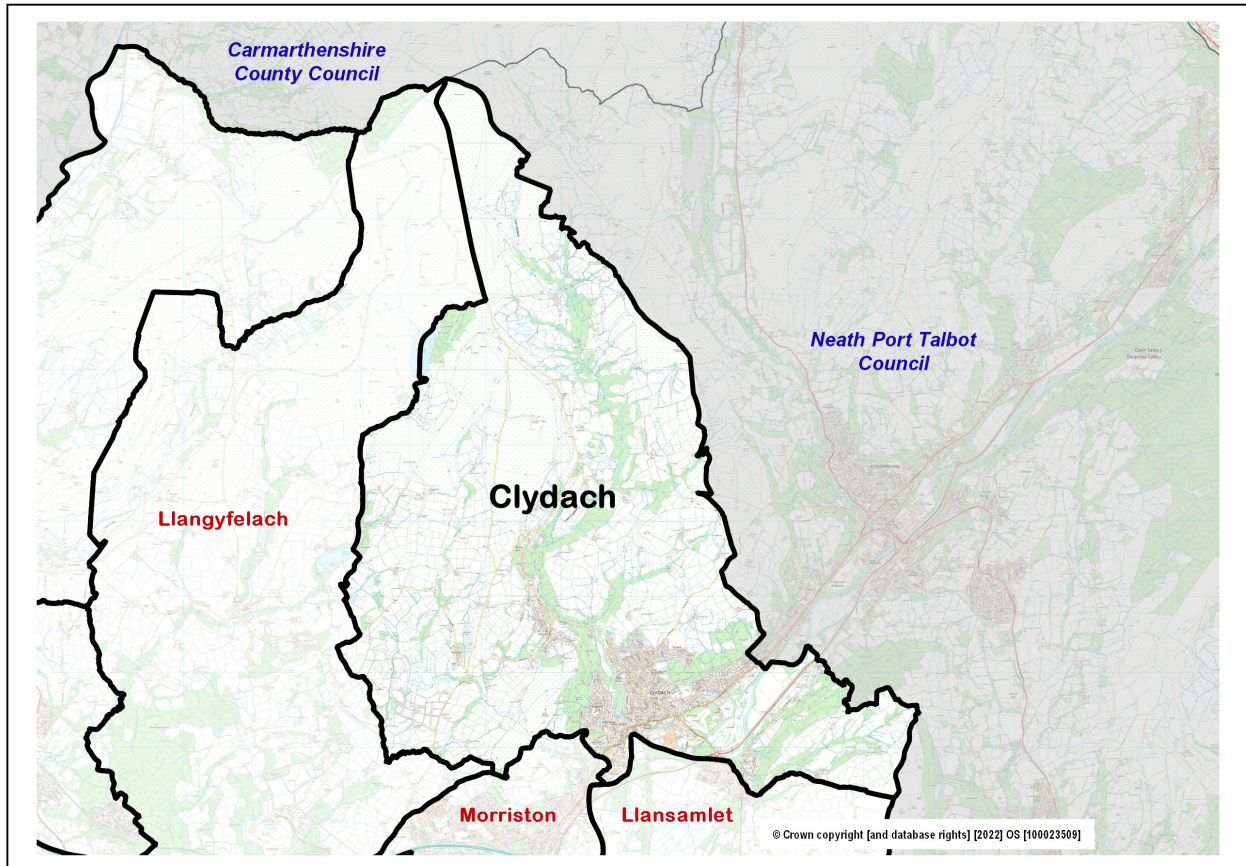


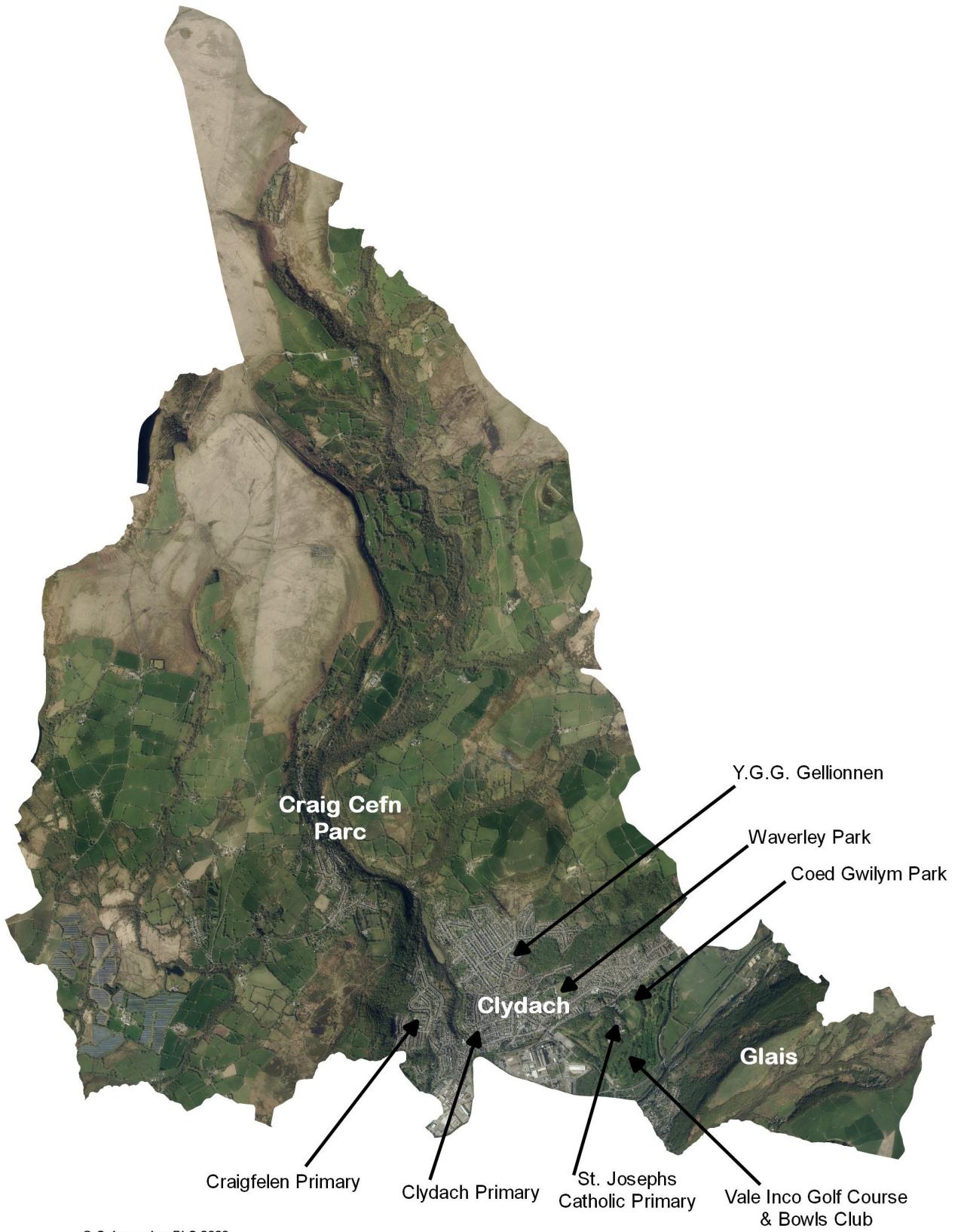

**Councillors (Electoral vote, May 2022):** Gordon Walker (Independent – 2,025); Matthew Bailey (Independent – 1,844); Brigitte Rowlands (Conservative – 1,003). *Turnout = 43%. Electorate: 6,790.*



- **Location:** Approximately 9.5 kilometres north-east of Swansea city centre, consisting of the localities of Graigfelen, Clydach, Craig Cefn Parc and Glais (part).
- **Adjacent Wards (Swansea):** Llansamlet, Morryston, Llangyfelach.
- **Electoral Ward Review 2022:** Changed – now consists of the former Clydach electoral ward plus part of the former Mawr electoral ward.
- **Constituency Area (Welsh Government / UK Parliament):** Gower.
- **Population** (Office for National Statistics rounded estimate, 2021 Census): 8,500.
- **Area:** 33.5 sq.km. **Population Density:** 254 people per sq.km (ONS, 2021)
- **Employment:** (former ward, ONS workplace estimate, 2021): 1,500. Major employers: Vale, Swansea Council (schools), Players Industrial Estate occupiers.

## ABOUT THE WARD

Clydach grew as a settlement during the 19th Century due to the industrial works located in the area and its location on the main road, rail and canal routes to the coal mines and works further up the valley. The emerging town further expanded at the start of the 20th Century with the opening of the Inco Mond works in 1902 (now Vale nickel refinery). The ward contains a core of older terraced housing. Subsequent years have seen the development of a significant amount of semi-detached housing and some detached homes, resulting in a mix of housing types and sizes across the ward. Over two-thirds of housing is owner occupied, above the Swansea average.

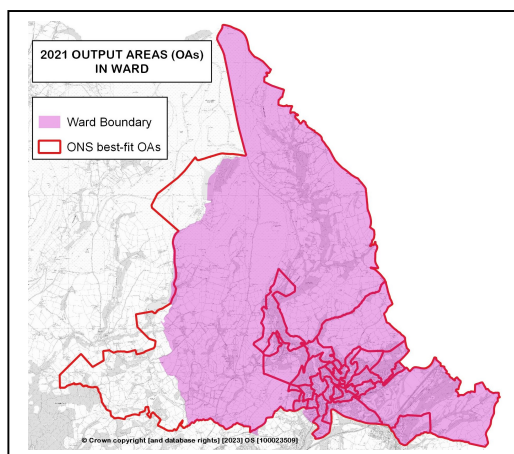
Craig Cefn Parc grew up around the coal mining and related industries, dating back to at least the 19th Century. Craig Cefn Parc is today a mixture of local authority housing, traditional semi-detached 'worker houses' and modernised, large detached properties.

A large area of the ward, mainly to its west and north, is now rural in character, comprising largely open upland green space and scattered farm developments.

### Summary

- 13th largest ward population in Swansea, and 6th lowest population density (2021).
- Relatively low proportion of people aged 16-24, but other groups close to Swansea average.
- High proportion of people able to speak Welsh.
- Slightly higher proportion of single family households aged 66+.
- Higher proportion of detached and semi-detached housing, low levels of flats, maisonettes and apartments.
- Economic activity categories relatively close to Swansea averages.

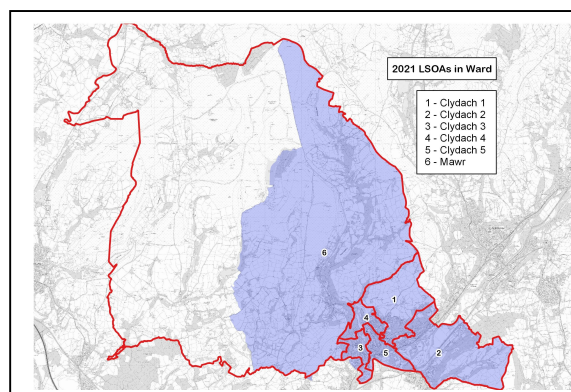
