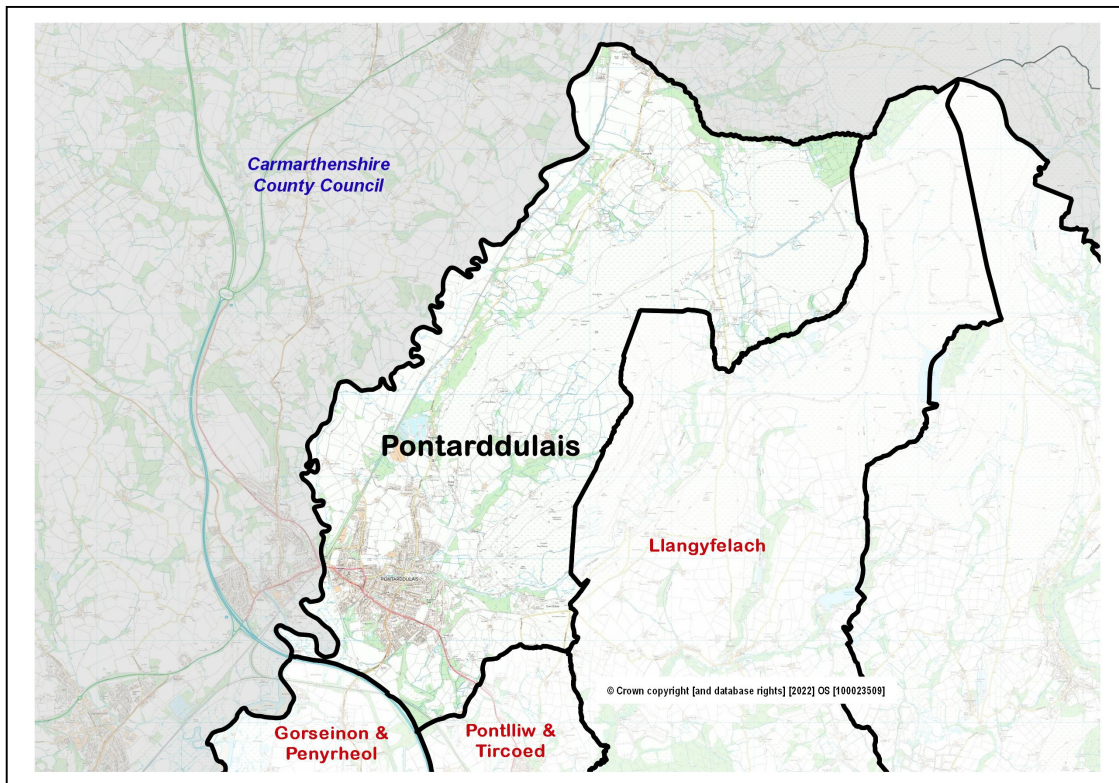


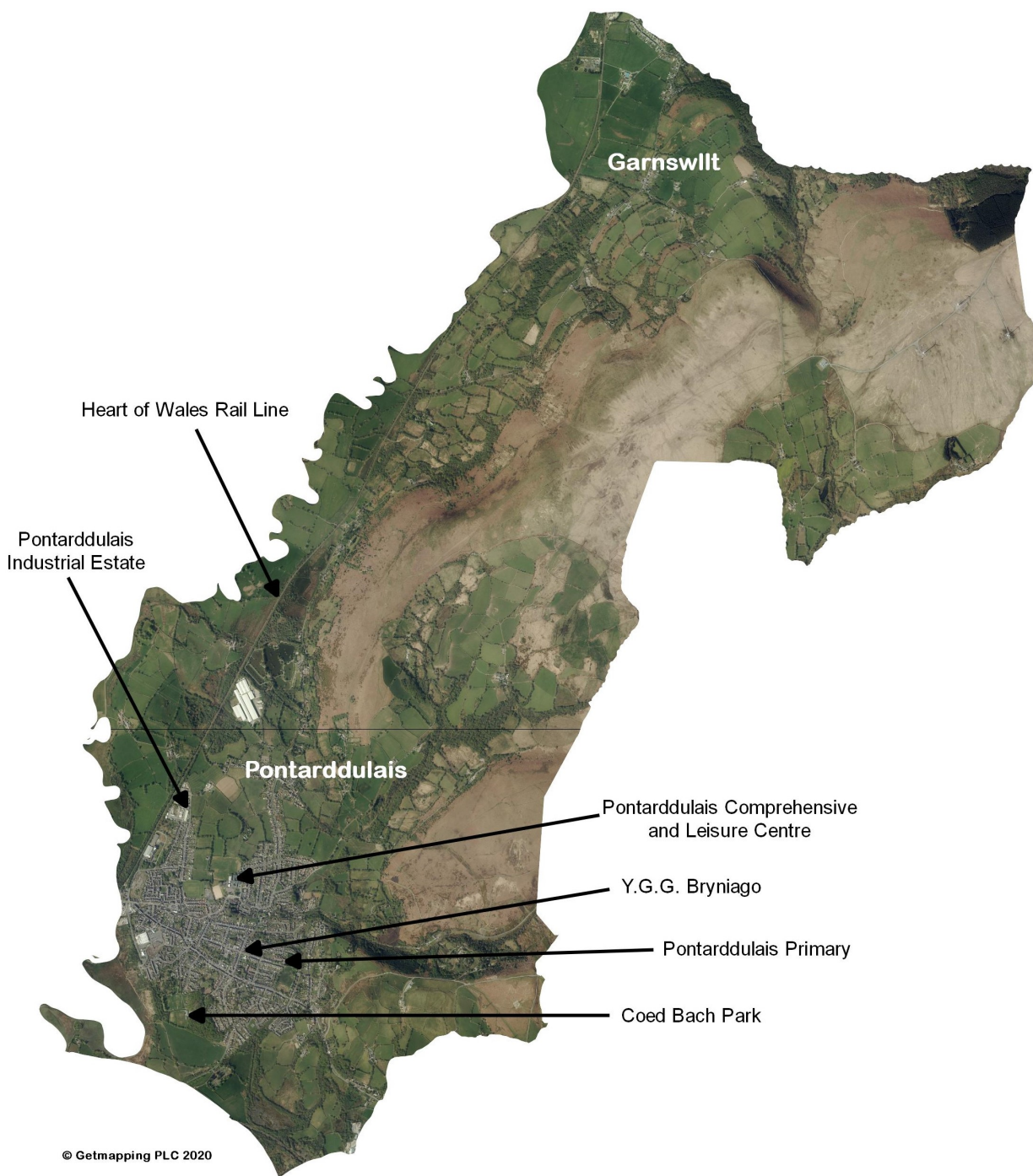

- **Location:** Approximately 12 kilometres north west of the city centre.
- **Adjacent Wards (Swansea):** Llangyfelach, Pontlliw and Tircoed, Gorseinon and Penyrheol.
- **Electoral Ward Review 2022:** Changed – the new electoral ward consists of the former Pontarddulais electoral ward plus part of the former Mawr electoral ward.
- **Constituency Area (Welsh Government / UK Parliament):** Gower.
- **Population (Office for National Statistics rounded estimate, 2021 Census):** 6,800.
- **Area:** 24.9 sq. km. **Population Density:** 275 people per sq. km (ONS, 2021)
- **Employment (former ward, ONS workplace estimate, 2021):** 1,500. Major employers: Tesco, district shopping centre, Pontarddulais Industrial Estate occupiers, Macmillan Distribution, Swansea Council (schools).

ABOUT THE WARD

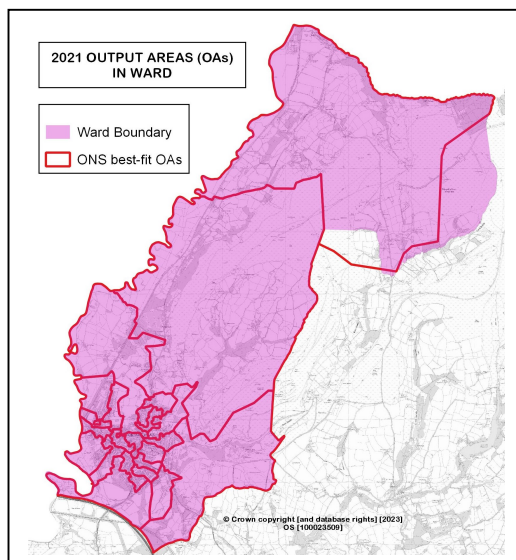
For centuries, Pontarddulais (or ‘The Bont’ as it is locally known) was a small hamlet built around a crossing point of the River Loughor. The first railway arrived in 1839 to transport anthracite from the Amman Valley to Llanelli, followed in 1866 by another line from Swansea and the Graig Merthyr coal mine in 1867. Heavy industry transformed Pontarddulais into a thriving industrial town, with six tinsplate works opening between 1872 and 1910, together with several mines.

Substantial population and housing growth followed in the early 20th century, although of course the general ‘de-industrialisation’ of the area in the post war years is also well documented. Pontarddulais’ housing market is closely linked with that of adjoining Hendy (Carmarthenshire), with both benefiting from proximity to the M4 motorway. The central and northern areas of the ward are essentially rural, including the extensive uplands and common land of Graig Fawr.

Summary

- 14th smallest ward population in Swansea, and 7th lowest population density (2021).
- Age profile relatively close to Swansea, but higher proportion of children (aged 5-15).
- Lower proportions of young people aged 16-24 years.
- Higher proportions of people able to speak Welsh and born in the UK.
- Slightly larger percentage of couple households.
- Above average proportions of detached and semi-detached housing and households owned with a mortgage or loan.
- Higher percentage of economically active adults and employees.

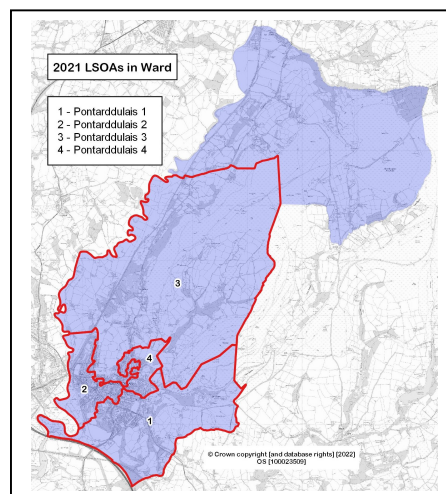
