ELECTION OF A MEMBER OF PARLIAMENT

SWANSEA EAST CONSTITUENCY

1. An election is to be held of a member to serve in Parliament for the said Constituency.
2. Nomination papers may be obtained from the Acting Returning Officer at The Guildhall, Swansea SA1 4PE, during normal office hours on any working day after the date of this notice. The Acting Returning Officer will, at the request of any elector, prepare for signature a nomination paper.
3. Nomination papers must be delivered to the Acting Returning Officer between the hours of 10 a.m. and 4 p.m. on any working day, but not later than 4pm on Thursday, 14 November, 2019.
4. If the election is contested, the poll will take place on Thursday, 12 December, 2019.
5. The deposit for each candidate (£500.00) can be paid by cash or bankers draft (banks operating in the UK only).
6. Electors and their proxies should take note that:
 - a) Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the address below by 5pm on 26 November, 2019.
 - b) Applications to vote by proxy at this election must reach the Electoral Registration Officer at the address below by 5pm on 4 December, 2019.
 - c) Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer by 5 p.m. on 12 December, 2019. The physical incapacity must have occurred after 5pm on Wednesday 4 December 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 4 December, 2019.
