## **ENFORCEMENT NOTICE**

### **OPERATIONAL DEVELOPMENT**



The Town and Country Planning Act 1990 (as amended)

### ISSUED BY THE CITY AND COUNTY OF SWANSEA ("The Council") COUNCIL REFERENCE ENF2022/0160

1. **THIS NOTICE** is issued by the Council because it appears to them that there has been a breach of planning control under Section 171A(1)(a) of the Town and Country Planning Act 1990 at the land described below. They consider that it is expedient to issue this Notice having regard to the provisions of the development plan and all other material planning considerations. The **annex** at the end of the Notice contains important additional information.

#### 2. THE LAND TO WHICH THIS NOTICE RELATES

Land at 98 Mumbles Road Blackpill Swansea SA3 5AS in the City and County of Swansea ("the Land"), shown edged red on the plan appended hereto ("the Plan").

# 3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission, the construction of a raised platform to the rear of the property.

#### 4. REASONS FOR ISSUING THIS NOTICE

It appears to the Council that the above breach of planning control has occurred within the last four years:

(i) The raised platform by virtue of its location and height fails to respect the residential amenity of the neighbouring properties contrary to Policy PS2 of the Swansea Local Development Plan (2010-2024) and the guidance contained within the Supplementary Planning Guidance 'Placemaking Guidance for Householder Development' (October 2021).

#### 5. WHAT YOU ARE REQUIRED TO DO

- (i) Remove the raised platform from the rear of the property.
- (ii) Remove all waste materials arising from the above operations from the land.

#### 6. TIME FOR COMPLIANCE

Two months beginning with the day on which this notice takes effect.

#### 7. WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on the 18<sup>th</sup> November 2022, unless an appeal is made against it before that date.

The fee payable in this instance is **£460**. #### WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this Enforcement Notice, it will take effect on the date specified in paragraph 7 of the Notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period(s) specified in paragraph 6 of the Notice. Failure to comply with the Enforcement Notice which has taken effect can result in prosecution and/or remedial action by the Council.
